Introductory statement

Prince Albert High is a 11-18 co-educational, non-denominational school providing an exciting, highly motivating and challenging education. The school has the highest expectations of its pupils regardless of starting point or any perceived disadvantage. Our aim is to produce well rounded, confident and responsible young people who will make a positive contribution to our society.

Aims

This policy aims to:

- explain how to apply for a place at the school;
- set out the school's arrangements for allocating places to the pupils who apply; and
- explain how to appeal against a decision not to offer your child a place.

Legislation and statutory requirements

As an academy, the school is required by its funding agreement to comply with these codes, and with the law relating to admissions as set out in the [School Standards and Framework Act 1998](#).

Admission number(s)

The school has an admission number of 180 for entry in Year 7.

The school will accordingly admit this number of pupils if there are sufficient applications. Where fewer applicants than the published admission number(s) for the relevant year group are received, the Academy Trust will offer places at the school to all those who have applied.

Application process for entry to Year 7 in September 2022

'Normal round' is relevant to all applications for a place in Year 7 starting at the beginning of the Autumn term in September.

PLEASE NOTE: This policy is not relevant to the process for naming the school on a child's Education, Health and Care Plan (EHCP) or Statement of Special Educational Needs. There is a separate process for selecting or changing the school named on an EHCP or Statement of Educational Needs which is outside of the admissions process. Please contact the child's home Local Authority for further details.

Application Process

Normal Round – Secondary (Year 7)

i. Applications for a place at the school are administered through the Birmingham City Council application process. Parents resident in Birmingham can apply online at: https://www.birmingham.gov.uk/info/20119/school_admissions; parents resident in other areas must apply through their home local authority.

ii. The Local Authority's timetable will be used for all normal round applications each year (exact dates within the months may vary from year to year).

iii. The school publishes information about the arrangements for admission, including oversubscription criteria, in February for the following September (e.g. in February 2021 for admissions in September 2022).

iv. Secondary application timetable: The school has an agreed PAN of 180 in Year 7.

1st September- 31st October 2021: The application period is open.

31st October 2021: National closing date for Secondary applications. Deadline for the Common Application Form to be completed and submitted to the relevant Local Authority.

November 2021 – February 2022: The school and Local Authority coordinate to process all applications. If more applications are received than places available they will be ranked according to the oversubscription criteria published in this policy, see below.

PLEASE NOTE: schools are not able to provide any information regarding specific applications during this process.

28 February 2022: Deadline for the school to publish its appeals timetable on their website.

1st March 2022: Offers made to parents/carers by the Local Authority

28th March 2022 - Parent/carers must complete any appeal forms for Birmingham community schools and the majority of academies and return them by Monday 28th March 2022 to Birmingham City Council, Directorate for People, School Admissions and Pupil Placement Service, PO Box 16513, Birmingham B2 2FF. Please visit the School Appeals Enquiry page for more information on how to appeal. If Parent/carers wish to appeal for schools or academies in other local authorities they should contact the relevant authority to establish their appeal arrangements.

May/June - Appeals that have been submitted on time for secondary schools will be heard.

6th July 2022 - Year 6 Induction Day - Primary children visit future secondary school.

5th September 2022 – Start school in Year 7

Oversubscription Criteria

When the school is oversubscribed, after the admission of pupils with an Education, Health and Care plan naming the school, priority for admission will be given to those children who meet the criteria set out below, in priority order:

1. Looked after children (LAC) and all previously looked after children (PLAC), including those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted (IAPLAC).
2. Children of staff who have been recruited to fill a skill-shortage area.
3. Children in Y6 who attend at the time of application one of the following primary schools in the Prince Albert Community Trust; Prince Albert Primary School, Heathfield Primary School and Birchfield School.
4. Children (siblings) with an older brother or sister, already at the school, who will still be in attendance at the time the sibling enters the school.
5. Children of UK service personnel (UK armed forces) who have a letter confirming they are going to be moving to the area.
6. Other children arranged in order of priority according to how near their home addresses are to the postal address of the school, determined by a straight-line, as the crow flies measurement.

Tie break

In a very small number of cases it may not be possible to decide between the applications of those pupils who are the final qualifiers for a place when applying the published admission criteria 2-5.

For example, this may occur when children in the same year group live at the same address, or if the distance between the home and school is exactly the same, for example, blocks of flats. If there is no other way of separating the application according to the admissions criteria and to admit both or all of the children would cause the Published Admission Number for the child's year group to be exceeded, the Local Authority will use a computerised system to randomly select the child to be offered the final place.

If twins or children from multiple births are tied for the final place, they will all be admitted and the school will operate over PAN.

Late applications

All applications received by the school after the deadline will be considered to be late applications. Late applications will be considered after those received on time. If, following consideration of all applicants the school is oversubscribed, parents may request that their child is placed on the school's waiting list.

Admission of children outside their normal age group

Parents may request that their child is admitted outside their normal age group. To do so parents should include a request with their application, specifying why admission out of normal year group is being requested.

When such a request is made, the Academy Trust will make a decision on the basis of the circumstances of the case and in the best interests of the child concerned, taking into account the views of the Headteacher and any supporting evidence provided by the parent.

Waiting lists

The school will operate a waiting list for each year group. Where the school receives more applications for places than there are places available, a waiting list will operate until the end of the first term after the beginning of the school year. This will be maintained by the Academy Trust and it will be open to any parent to ask for his or her child's name to be placed on the waiting list, following an unsuccessful application.

Children's position on the waiting list will be determined solely in accordance with the oversubscription criteria. Where places become vacant they will be allocated to children on the waiting list in accordance with the oversubscription criteria. The waiting list will be reordered in accordance with the oversubscription criteria whenever anyone is added to or leaves the waiting list.

Appeals

All applicants refused a place have a right of appeal to an independent appeal panel constituted and operated in accordance with the School Admissions Appeals Code.

Review

This policy will be reviewed annually.

Whenever changes to admission arrangements are proposed (except where the change is an increase to the agreed admission number), the Trust will publicly consult on these changes.

Notes

Home address:

The home address is where a child normally lives. Where a child lives with parents with shared parental responsibility, each for part of a week, the address where the child lives is determined using a joint declaration from the parents stating the pattern of residence. If a child's residence is split equally between both parents, then parents will be asked to determine which residential address should be used for the purpose of admission to school. If no joint declaration is received where the residence is split equally by the closing date for applications, the home address will be taken as the address where the child is registered with the doctor. If the residence is not split equally between both parents, then the address used will be the address where the child spends the majority of the school week.

Sibling:

'Sibling' means a natural brother or sister, a half brother or sister, a legally adopted brother or sister or half-brother or sister, a step brother or sister or other child living in the same household as part of the same family, who, in any of these cases, will be living at the same address at the date of their application for a place.
